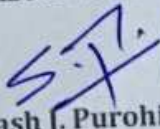

मुंबई : पाणी फाउंडेशनच्या वॉटर कप स्पर्धेच्या निमित्ताने पाणलोट क्षेत्रात मोठे काम झाले आहे आणि लोकांमध्ये जनजागृती आली आहे. मात्र त्या सोबतच आतामाती, गवत आणि पीक नियोजनावर काम करावे लागेल. तेव्हाच आपण दुष्काळाला पूर्णपणे हरवू शकू, असे प्रतिपादन प्रसिद्ध अभिनेते आणि पाणी फाउंडेशनचेसंस्थापक अमिर खान यांनी येथे केले. वॉटर कप स्पर्धा २०१९ हे तालुका व राज्यस्तरीय पात्रितोषिकांचे वितरण रविवारी बालेवाडी येथील शिवछत्रपती क्रीडा संकुलात झाले. यावेळी खान बोलत होते. या कार्यक्रमाला चित्रपट व क्रीडा क्षेत्रातील अनेक नामवंतांची उपस्थिती होती. रिलायन्स फाउंडेशनचे सचिव मर्डीकर, एच. टी.पारेख फाउंडेशनच्या झिया लाल, पिरामल फाउंडेशनचे आर. चंद्रशेखर, टाटा ट्रस्टचे पवित्रकुमार आणि बजाज फाउंडेशनचे अरविंद जोशी यावेळी प्रामुख्याने उपस्थित होते. या स्पर्धेत जिंकणे किंवा हरणे हे महत्त्वाचे नसून गावागावांत पाणलोटचे महत्त्व पोचले पाहिजे, हे अधोरेखित करून अमिर खान म्हणाले म्हणाले, की आमच्यादृष्टीने भाग घेणारी सर्व गावे ही विजेतीच आहेत. दुष्काळाला आपण अजून हरवलेले नाही. आपण गाफील राहिलो तर



दुष्काळ परत येऊ शकतो. मात्र हा मार्ग सोपा नाही. पाणलोट कामासोबतच माती, गवत आणि पीक नियोजनावर काम करावे लागेल. तेव्हाच आपण दुष्काळाला पूर्णपणे हरवू शकू. यावेळी बोलताना किरण रावम्हालाय्या, की राज्यात व देशात निर्माण झालेल्या पुरस्थितीचा विचार करून आम्ही हा कार्यक्रम साधेपणाने करण्याचा निर्णय केला. यंदाची स्पर्धा अत्यंत कठीण वातावरणात असल्याचे सांगून पाणी फाउंडेशनचे मुख्य कार्यकारी अधिकारी सत्यजीत भटकर म्हणाले, यंदाचे हे स्पर्धेचेवर्षे वर्ष आहे मात्र आपणपर्यंत एवढी खडतर परिस्थिती कधीही नव्हती. स्पर्धा घ्यावी की नाही अशी शंका यायला लागली होती कारण गेल्या वर्षी पाऊस कमी झाला होता आणि स्पर्धेच्या काळातच निवडणुका आल्या. तरीही यंदा ४७२६ गावांनी प्रशिक्षण घेतले आणि त्यातील ४१५४ गावांनी प्रत्यक्ष स्पर्धेत सहभाग घेतला.
