I certify that:

1. I possess relevant expertise and experience to be an independent director in the Company;
2. (i) I am/was not a promoter of the company or its holding, subsidiary or associate company;

(ii) I am not related to promoters / directors in the company, its holding, subsidiary or associate company;
3. I have/had no pecuniary relationship / transactions other than remuneration or having transaction not exceeding 10% of total income as such director, with the company, its holding, subsidiary or associate company, or their promoters, or directors, during the two immediately preceding financial years or during the current financial;
4. None of my relatives
 - i. hold any security of or interest in the company of face value not exceeding fifty lakh rupees or two percent of paid up capital of the company, its holding, subsidiary or associate company during the two immediately preceding financial years or during the current financial year;
 - ii. is indebted to the company, its holding, subsidiary or associate company or their promoters, or directors, in excess of such amount of Fifty lakhs rupees during the two immediately preceding financial years or during the current financial year;
 - iii. has given a guarantee or provided any security in connection with the indebtedness of any third person to the company, its holding, subsidiary or associate company or their promoters, or directors of such holding company, for such amount of Fifty lakhs rupees during the two immediately preceding financial years or during the current financial year;
 - iv. has pecuniary transaction or relationship with the company, or its subsidiary, or its holding or associate company amounting to two percent or more of its gross turnover or total income singly or in combination with the transactions referred to in sub-clause (i), (ii) or (iii);
5. either me nor any of my relatives:
 - i. holds or has held the position of a key managerial personnel or is or has been employee of the company or its holding, subsidiary or associate in any of the three financial years immediately preceding the financial year;
 - ii. is or has been an employee or proprietor or a partner, in any of the three financial years immediately preceding the financial year of;

- a. a firm of auditors or company secretaries in practice or cost auditors of the company or its holding, subsidiary or associate company; or
- b. any legal or a consulting firm that has or had any transaction with the company, its holding, subsidiary or associate company amounting to 10% or more of the gross turnover of such firm;
- iii. holds together with my relatives 2% or more of the total voting power of the company;
or
- iv. is a Chief Executive or director, by whatever name called, of any nonprofit organization that receives 25% or more of its receipts from the company, any of its promoters, directors or its holding, subsidiary or associate company or that holds 2% or more of the total voting power of the company; or
6. I possess appropriate skills, experience and knowledge in one or more fields as mentioned in Rule 5 of The Companies (Appointment and Qualification of Directors) Rules, 2014.
7. I am not less than 21 years of age.
8. I have complied with the sub (1) and (2) of Rule 6 of Companies (Appointment and Qualification of Directors), Rules, 2014.
9. I have complied with the criteria of independence as provided in clause (b) of Sub-regulation (1) of regulation 16 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and that I am not aware of any circumstances or situation, which exist or may be reasonably anticipated, that could impair or impact his ability to discharge his duties with an objective independent judgment and without any external influence.


Declaration
